










Award criteria

- 7. Sustainability.










Assessment of award criteria

- Threshold of min. 75% of 35 points.
- Some criteria need min. 3,5 / 5:

 - Specific objectives;
 - Level of excellence of the activities proposed.











Selection 2008 Selected projects by Objective








Selection 2008 – Selected proposals by Themes

Who can participate?

I.e.: University, Municipality, Theatre, Museum, National Park, Orchestra, Festival, Cultural Network Organisation,...

- Public or private organisation with legal personality in field of culture; non profit making;
- Legal registered seat in one of the countries participating in the Culture Programme:
 - 27 EU-Member States
 - EEA countries (Iceland, Liechtenstein, Norway)
 - Candiate Countries to EU (Croatia, Turkey, FYRO Macedonia) and Serbia





Who is who?

- <u>Coordinator</u>: overall responsible for action, signs the grant agreement.
- <u>Co-organiser/s</u>: concrete and essential involvement in implementation and financing in the project; mandate to be signed.
- <u>Associated partner/s</u>: takes part in implementation of project, costs are not eligible unless directly paid or refunded by coordinator and/or co-organisers.






Simplifications

• Application form reduced 50 – 17 pages



- Fixed deadline for submission: 1st October each year
- One phase for submission only
- Estimated budget automatised, from 18 to 4 pages



Culture Infoday 2008 I. EXPENDITURE




1. Costs directly linked to the implementation of project activities
